DUES STRUCTURE

Producer member dues are payable on a quarterly basis and reported beginning January 1, April 1, July 1, and October 1 for the previous quarter's tonnage. Dues are to be paid on all tonnage produced including recycled materials in all states and/or U.S. territories or possessions. If annual production is around 51,500 tons, then the minimum dues are \$2,160. There is a \$1,000 initial membership application fee for all new Producer members, and quarterly reporting begins after the application is received. The fee must accompany the membership application.
